Description of the location

Fairways Residential Care Home is a 69 bed care home, located near the seaside resort of Bournemouth in Dorset. Only half a mile from Boscombe Pier, it is perfect for visiting family and friends as it is close to Bournemouth's seven miles of award winning beaches. The home is a 10 minute walk to Boscombe Pier with good access to public transport

The home comprises of an older period building with a modern purpose -built extension with a total of 67 bedrooms all with en suite facilities. Residents have a choice of two communal lounges and two communal dining areas. There is a designated activities area at one end. Residents can listen to music and watch TV in there should they wish.

The home employs Activity officers who offer a wide range of activities designed to encourage residents to take an interest in different aspects of life, taking into account individual resident's interests, skills, personalities and medical conditions .

The smaller lounge is in a separate part of the home and is a quiet alternative to the large lounge.

Outside the home there is an enclosed courtyard area and a small fenced garden area for residents to access.

The home is arranged over 3 floors, with two lifts accessed via either end of the home.

The home aims to provide care for people over the age 65, but may consider admission of a person under 65 if a thorough assessment supports this and enables the Registered Manager to confirm that the home can meet the individual's needs/outcomes.

Facilities offered include; free internet access, hairdressing, chiropody, library service, multi faith church services and a range of other social activities.

The home ensures there are adequate numbers of management, care and domiciliary staff on duty during the day and night to meet the needs of all residents. Staff are trained, according to their role, in line with national guidelines, to ensure that all staff have the appropriate knowledge and skills to meet the needs of residents.

We work closely with other professionals in Health and Social care which includes District Nurses, Community Mental Health Team, Social Workers, Opticians and Chiropractors. The home is served by seven GP practices all which come to the home to offer a regular clinic session to residents. One on a weekly basis to support and advise staff and residents in relation to moving and handling needs.

The ethos of the home is to support residents to live well and we actively promote Person Centred Care through care planning processes and ensuring choice is given to all residents in all aspects of their daily lives.
